Our focus is to ensure children meet their developmental milestones, are ready to succeed when they start kindergarten, and develop a lifelong love for learning. We strengthen the impact for our children by engaging their parents in the learning process, recognizing parents are the first teachers for their children. Our Center is a part of the elite Excellence Academy and Stars for Kids Now program.**
